

## Elections of the EHEDG Advisory Board effective as of 1 January 2021

### - Call for Advisory Board Candidates -

Dear EHEDG Members,

As communicated in our letter dated 1 July, please be informed that the EHEDG Advisory Board is going to be elected once every two years as specified in our Statutes (Articles 10 -11, page 8), in our Internal Rules (Article 6, page 13), and in Bylaw No. 1 on "Election Procedures". Please duly take note of these documents which are attached to this call.

The EHEDG Advisory Board will be elected by the **General Assembly**, consisting of each one designated representative of an industry company or institute member as a voting entity.

In order to establish a continuity for the future for the 2020 election only, the Advisory Board will be elected for 2 years and 4 years respectively.

**The election is planned for quarter 4/2020 and the Advisory Board is going to start its term as of 1 January 2021 with a constitutional meeting in the same month.** The election of the Advisory Board members will be for a period of 2 years for 3 of the members, and 4 years for the other 3 members. The detailed voting procedure including all other relevant information will be consecutively communicated by the EHEDG Secretariat via direct E-mailings in the coming weeks.

**We hereby call for the nomination of six Advisory Board candidates at large being the representatives of the EHEDG member companies**, but not necessarily of the same company or institute who is nominating the candidate. The Advisory Board at large should preferably consist of two representatives from food producers, two from equipment manufacturers and two from service suppliers or engineering companies. The Advisory Board will be chaired by the EHEDG President (see separate call). All rights and duties of the future Advisory Board members are described in the attached EHEDG Statutes and in Bylaw no. 1. Apart from this, Advisory Board members are expected to:

- physically meet at least once a year as specified in the statutes (first meeting in January 2021)
- adequately prepare themselves for meetings and take note of all related communication
- reserve about 3 to 4 days a year for their EHEDG work
- have a global and strategic view as well as leadership skills
- have knowledge in food safety and hygienic engineering & design
- be prepared to participate in the Advisory Board on a regular basis at own cost.

Proposed candidates, including their CV and motivation letter (see attached templates), must be communicated to the EHEDG Secretariat **at the latest until 15 September 2020**. The detailed voting procedure, names of candidates and other relevant information will be published on the EHEDG website by the EHEDG Secretariat as well as communicated directly to the designated General Assembly representatives, one month before the election date.
